



**GET *ALL* THE CREDITS & REFUNDS YOU DESERVE
WITH FREE TAX PREPARATION**



- **Individuals who make under \$14,000 a year** and Families making under **\$49,000 a year** should take advantage of Volunteer Income Tax Assistance (VITA) sites and get your tax-return prepared for free.
- VITA trained volunteers help you claim **all** the tax credits you *deserve*, including the Earned Income Tax Credit or E-I-T-C. You can also get your refund within **two weeks** with free e-filing and direct deposit.

WHAT YOU MUST BRING:

- Photo ID and original Social Security cards or Individual Tax Identification Number (ITIN) for yourself, your spouse, and all dependents.
- All W-2s, 1098, 1098-G and 1099.

PLEASE BRING, IF YOU HAVE:

- Child care costs for 2009, including name, address and social security number of childcare provider.
- A copy of last year's tax return
